

## Public Disclosure

The following programs have been found to be non compliant with one or more of CAMPEP standards. These programs maintain their accreditation while these issues are addressed and are required to report on progress towards meeting the standards annually.

- Medical University of South Carolina Therapy Physics Residency Program (December 23, 2015)
  - Non-compliance with CAMPEP Residency Standard 7.3: “All clinical, educational and scholarly activities engaged in by the resident shall be recorded in an activities journal using any appropriate format maintained personally by each resident and examined periodically by the Program Director.”
- Memorial Sloan Kettering Cancer Center Imaging Physics Residency Program (October 26, 2016)
  - Non-compliance with CAMPEP Residency Standard 2.5: “The steering committee shall review the educational program annually and take appropriate action to address improvements when needed. Minutes of steering committee reviews, including a summary of any actions that are proposed or taken, shall be recorded.”
- University of Arizona Therapy Physics Residency Program (October 26, 2016)
  - Partial compliance with CAMPEP Residency Standard 2.3: “Resident education shall be supervised and monitored by an appropriate steering committee, which is chaired by the program director or delegate and meets formally at least twice a year. Committee membership shall include the program director and relevant staff involved in residency education including a physician and the chief (or a senior) dosimetrist. The process for appointment of the members of the steering committee shall be documented. Minutes of meetings shall be recorded.”
  - Partial compliance with CAMPEP Residency Standard 2.5: “The steering committee shall review the educational program annually and take appropriate action to address improvements when needed. Minutes of steering committee reviews, including a summary of any actions that are proposed or taken, shall be recorded.”
  - Partial compliance with CAMPEP Residency Standard 4.8: “The program director shall meet periodically with each resident to assess the resident’s progress, and minutes of the meeting shall be maintained. A copy of the minutes shall be provided to the resident.”
- Genesis Health Care Therapy Physics Residency Program (October 26, 2016)
  - Non-compliance with CAMPEP Residency Standard 2.1: “The institution in which the clinical training is conducted must be accredited by the appropriate healthcare accreditation organization”
- University of Florida Certificate Program (December 14, 2016)
  - Significant non-compliance with CAMPEP Graduate Standards 8.3 and 8.6: Multiple specific curriculum topics must be added to this program.

- Université de Montréal Graduate Program (November 27, 2017)
  - Non-compliance with CAMPEP Graduate Standard 2.9: “A graduate program that has tracks that are not CAMPEP-accredited must clearly identify those students who are enrolled in the accredited program.”
- Western University Graduate Program in Medical Physics (November 26, 2017)
  - Non-compliance with CAMPEP Graduate Standard 2.3: “Graduate education shall be supervised and monitored by an appropriate steering committee, which is chaired by the program director or delegate and meets formally at least twice a year.”
- Stony Brook University Graduate Program (January 29, 2018)
  - Non-compliance with CAMPEP Graduate Standards 8.3 Fundamentals of Medical Imaging and 8.6 Radiation Therapy Physics: Specific curriculum topics not addressed.
- University of Alberta Graduate Program (March 9, 2018)
  - Non-compliance with CAMPEP Graduate Standard 2.3: Graduate education shall be supervised and monitored by an appropriate steering committee, which is chaired by the program director or delegate and meets formally at least twice a year.
- Columbia University/Cornell University (April 10, 2018)
  - Non-compliance with CAMPEP Graduate Standard 2.3: Graduate education shall be supervised and monitored by an appropriate steering committee, which is chaired by the program director or delegate and meets formally at least twice a year.
- The following graduate programs are in non-compliance with CAMPEP Graduate Standard 2.10: “An accredited program must publicly describe the program and the achievements of its graduates, preferably through a publicly-accessible website.
